17. **SUBJECT:** COMMUNITY DEVELOPMENT DEPARTMENT REORGANIZATION.

RECOMMENDATION: That City Council:

1. Adopt Resolution No. 2008-02, amending Resolution No. 2007-24, adopting the General Unit Salary, Benefit and Classification Plan, and amending Resolution 2007-25, adopting the Management, Supervisory and Confidential Salary, Benefit and Classification Plan, effective with the pay period beginning on January 18, 2008, by reallocating the position of Associate Planner (General Employees Range 35, \$56,503-\$70,564) to the position of Planning Manager (M.S.C. Range 41, \$67,777-\$84,645), and
2. Decrease the Planning Division budget for salaries and related expenses by the amount of \$30,895 for fiscal year 2007/2008 to reflect the reallocation for approximately six months.

That the Redevelopment Agency amend the 2007/2008 Budget and

3. Approve the allocation of \$20,140 from the Low-Moderate Income Housing Fund, and
4. Approve the allocation of \$20,140 from the Capital Projects fund for a total allocation for fiscal year 2007/2008 in the amount of \$40,280 to reflect the reallocation for approximately six months.
