SO YOU WANT TO HAVE A YARD SALE! You've finished with your spring cleaning—straightened out the garage, cleaned out the closets, thrown out all the junk, but you've got some real "TREASURES" left that are just too good to give away or toss. So you're ready to stay home all weekend—set up the tables—put up the signs—sit back with a tall, cool glass of lemonade and make a little extra cash!

But hold on—the City of Yucaipa has just enacted an ordinance to regulate yard sales—so you need to know the rules:

1. Only four (4) yard sales per calendar year are permitted.
2. The yard sale does require a permit, (the first sale is free), but the 2nd, 3rd, and 4th is \$2.50 each.
3. Each sale is limited to three (3) consecutive days, and **there can be no consecutive sales.**
4. Sales can only be held between 8:00a.m. and 8:00p.m.
5. Items for sale cannot be placed in the **public right-of-way** and can only be displayed during the sale. (You must put them away when the sale is over!).
6. **YOU CAN ONLY HAVE ONE (1) SIGN ADVERTISING YOUR SALE AND IT MUST BE ON THE PROPERTY WHERE THE SALE IS BEING HELD. (No signs on utility poles or in the public right-of-way!).** It can be double faced, not larger than six (6) square feet and no higher than four (4) feet. You can post the sign up to twenty-four (24) hours before the sale, but is must be removed **immediately** following the sale.

City Code Enforcement Officers are now enforcing this ordinance and since, most yard sales occur on weekends, they will adjust their work schedules to provide proper coverage. Since this is a new ordinance, initial enforcement efforts will focus on making people aware of the law rather than issuing citations for violations.
