

RESOLUTION NO. 91-73

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF YUCAIPA, CALIFORNIA, ESTABLISHING THE TRAILS AND OPEN SPACE COMMITTEE OF THE CITY OF YUCAIPA

WHEREAS, the City Council is desirous of encouraging citizens from the community to participate in and serve on city advisory committees, and

WHEREAS, City committees have a primary role - to encourage increased public input and citizen participation in the determination of City policies and procedures.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF YUCAIPA, CALIFORNIA, DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. That a Trails and Open Space Committee consisting of nine members is hereby established.

Section 2. That membership on the Trails and Open Space Committee shall occur through appointment by the Mayor and each Councilmember with four members being appointed at large. Terms shall be consistent with appointed Council term with at large terms being two members with two-year terms from January 1 to January 1 and two members with four-year terms from January 1 to January 1, selected by lot.

Section 3. That the Trails and Open Space Committee shall follow the Rules of Procedure for committee meetings, related functions and activities, as found in Resolution 91-69.

Section 4. That the following are the Powers and Duties of the Trails and Open Space Committee.

- 4.1 That the Trails and Open Space Committee shall make recommendations to Council, implementing directives as related to the City's Master Trails Plan.**
- 4.2 That the Trails and Open Space Committee shall make recommendations to Council, implementing directives as related to the acquisition and maintenance of public open space.**
