Governor Newsom issued Executive Orders (N-25-20 and N-29-20), which temporarily suspend certain requirements of the Brown Act. Pursuant to the Executive Orders, Committee Members may attend meetings telephonically and the City is not required to make available a physical location from which members of the public may observe the meeting and offer public comment.

On March 19, 2020, the Governor issued Executive Order N-33-20, directing that all individuals living in the State of California stay at home or their place of residence except as needed to maintain the continuity of operations of designated federal critical infrastructure sectors.

Consistent with the Governor's Executive Orders, please be advised all the Vector Control Committee Members will attend this meeting telephonically.

Due to the essential nature of City meetings in conducting official City business, the Vector Control Committee meeting will take place as scheduled, with the following changes and alternate opportunities for public participation:

1. **E-MAILED PUBLIC COMMENT.** Members of the public that wish to address the Committee during public comment or a public hearing may submit public comments via email to [publiccomment@yucaipa.org](mailto:publiccomment@yucaipa.org). The subject line should specify "Public Comment" and include the date of the meeting. Providing your name and address is optional. Emails received by 1:00 p.m. the day of the meeting will be read out loud into the public record. Please keep in mind that all public comment is limited to three minutes. All email comments must be received by 1:00 p.m. the day of the meeting.


