CONVENE CITY COUNCIL

The meeting was opened with the Pledge of Allegiance led by Captain Onodera.

STUDY SESSIONS

SUBJECT: CALIFORNIA PROPOSITION 47 UPDATE STUDY SESSION

RECOMMENDATION: That City Council conduct a Study Session and:

1. Receive the update on the effects of Proposition 47; and
2. Provide further direction to staff, as appropriate, for the continued progression of law enforcement efforts.

DISCUSSION: Police Captain Onodera presented the Agenda Report.

Adam Wagner, Yucaipa, stated that he is unhappy with Proposition 47 and frustrated with the lack of recourse and suggested the possibility of increasing the number of law enforcement officers.

Vanessa Register, Yucaipa, stated that she finds it ironic that Proposition 47 is listed as the Safe Neighborhoods and Schools Act with the increase in crime and doesn't know how to fix the problem and asked what the residents need to do to address this issue.

After discussion, Council directed staff to draft a letter to the State legislature, for the record, outlining the problems originating from the passage of Proposition 47, to develop a strategic plan based on input received from Council and return with a Service Level

Option, and to direct City Attorney Snow to research the possibility of effecting a local law to address multiple misdemeanor offenders.

2. **SUBJECT:** UPTOWN BUSINESS DISTRICT PARKING ANALYSIS UPDATE

RECOMMENDATION: That City Council review the updated Uptown Parking Analysis and provide direction regarding the parking policy for the Uptown District.

DISCUSSION: Director of Community Development Toomey presented the Agenda Report.

After discussion, Council directed staff to retain the space immediately west of the YPAC parking lot for parking, to not incorporate metered parking or time management parking, to return to Council with a general concept for an in-lieu fee program, and to consider the potential for property acquisition for additional public parking where it may be economically feasible in the Uptown District.


