### OBSERVATIONS:

Fania flies were observed in coops 5 thru 7 again. Many sites (under all coops) were inspected for evidence of larvae.

In coop #4 (with the dirt floor), compacted manure was inspected in a couple of areas and no larvae were discovered. All coops were treated with insecticide (spray) on Mondays, November 5<sup>th</sup> and 12<sup>th</sup>, and Thursdays, November 8<sup>th</sup> and 15<sup>th</sup> 2018, and Fridays, November 16<sup>th</sup>, 2018 (Triazicide) of last two weeks. Fly traps were rejuvenated on Tuesdays, November 6<sup>th</sup> and 13<sup>th</sup>, 2018.

Spilled feed (between and below) and some compacted manure (below) below coops 1-3 and 5-7 is still an issue that needs to be remedied (found no larvae in any spilled feed). Owner has been told to sweep up the feed and scrape the compacted manure before next inspection.

There were several leaks and broken cups that needed to be repaired immediately.

### RECOMMENDATIONS:

- Maintain removal of chicken manure per the Manure Management Plan requirements (logs faxed to the City every Monday).
- Clean up excessive spilled feed between and under the coops. Remove compacted manure (hand scrape with scraper if necessary) under all of the concrete coops before next inspection.
