Individuals should be aware that comments provided, including personal information, may be disclosable pursuant to the California Public Records Act.

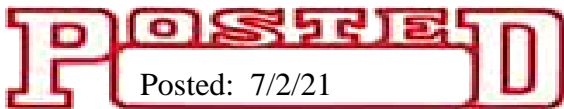
